



CASH DEPOSITING TERMS AND CONDITIONS

The donation is made to: Wielka Orkiestra Świątecznej Pomocy, ul. Dominikańska 19C, 02-738 Warsaw, entered into the register of associations, other social and professional organizations, foundations and public health care facilities of the National Court Register under KRS number 0000030897, kept by the District Court for the capital city of Warsaw in Warsaw, 13th Commercial Division, NIP Tax ID No 5213003700, REGON Statistical ID No 010168068, telephone number: 22-852-32-14 or 22-582-32-16, for and on behalf of which donations are accepted at ATMs by Euronet Polska sp. z o.o. with its registered office in Warsaw (00-189), 4C Inflancka street, entered into the Register of Entrepreneurs held by the District Court for the capital city of Warsaw in Warsaw, 12th Commercial Division of the National Court Register under KRS number 0000030408, NIP Tax ID No: 5261030333, REGON Statistical ID No: 011163179, share capital of PLN 57,904,000, helpline number: 0801 324 024, 22 519 77 71.

There is no fee for making the donation. The donation shall only be accepted in Polish zloty and up to the amount of PLN 500 at one time. The overall amount of deposits made in favour of all non-governmental organisations cooperating with Euronet may not exceed PLN 4,000 in one calendar year. In order to make a deposit, select the non-governmental organisation, accept the regulations and provide your PESEL number, as well as:

- for card donations insert card into the ATM, enter the card's PIN number and select the amount to be donated. Only cards bearing the VISA and MasterCard logos shall be accepted,
- for cash donations insert banknotes to be deposited into the ATM and confirm. Cash donations shall only be possible at ATMs which accept cash.

Card donations may only be made by persons authorized to use the given bank card.

Donations shall be accepted:

- for bank cards the moment the card transaction is approved,
- for cash the moment the amount is confirmed.

Accepted donations will be confirmed by an ATM receipt. Complaints shall only be considered with a valid receipt. If you have any complaints, please contact Euronet Polska. If you want to cancel the donation, please contact the Wielka Orkiestra Świątecznej Pomocy. Complaints shall be handled within 14 calendar days of receipt.

The personal data controller is Fundacja Wielkiej Orkiestry Świątecznej Pomocy (the Great Orchestra of Christmas Charity Foundation), ul. Dominikańska 19C, 02-738 Warsaw. The data is processed in order to accept the donation and will be stored for the period required by applicable law. To the extent necessary to make the donation, the personal data collected are provided to Euronet Polska sp. z o.o. with its registered office in Warsaw (00-189), ul. Inflancka 4C. Donors have the right to access their data and to have the data rectified or deleted or have its processing limited, the right to data portability and the right to bring a complaint to the supervisory authority. Provision of data is voluntary, yet necessary to complete a donation.

In accordance with Article 13 (1) and (2) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016, the Great Orchestra of Christmas Charity Foundation (WOŚP) informs that:

- 1) your personal data is controlled by the Great Orchestra of Christmas Charity Foundation (WOŚP) with its registered office at ul. Dominikańska 19c in Warsaw 02-738; tel.: 22 852 32 14,
- 2) should you have additional questions regarding personal data protection at the Great Orchestra of Christmas Charity Foundation, please write to the e-mail address: ochronadanych@wosp.org.pl;
- 3) We need your personal data processed during payment in order to accept your donation (Article 6(1)(c));
- 4) your personal data may be received by subcontractors of the Great Orchestra of Christmas Charity Foundation, in the scope of services provided by them (including IT services), in accordance with signed agreements. They are not entitled to use your data for their own purposes.
- 5) Your personal data will not be transferred to a third country or to an international organisation.
- 6) Your personal data will be stored for a period of 6 years from the date of payment in order to comply with the legal obligations and limitation of possible claims;
- 7) you have the right to access the content of your data, the right to rectify and erase the data and to restrict its processing, the right to data portability, the right to object, the right to withdraw consent at any time, unless we have valid legitimate grounds which override your interests, rights and freedoms;
- 8) you have the right to lodge a complaint with a supervisory authority (Personal Data Protection Office) if you believe that the processing of your personal data violates the provisions of the General Data Protection Regulation of 27 April 2016;
- 9) your provision of personal data is a condition for making a donation; if you do not provide the data, you will not be able to make a donation via an ATM;
- 10) Your data will not be processed by automated means or in the form of profiling.
